TERMS & CONDITIONS

Hereinafter called (“Exhibitor”) and Tulip Time Run. The parties to this contract agree as follows:

1. The Exhibitor shall pay the sum of \$150 upon signing this agreement (Exhibitor fee) unless you are a run sponsor.
2. In consideration for payment of the Exhibitor fee, Tulip Time Run hereby grants Exhibitor the right to participate in the Race & Fitness Expo. Exhibitors will derive benefit in the form of public exposure to their products and services.
3. The Exhibitor will receive a booth space which includes one 8’ table and two chairs. Sorry, there is no power, water, or Wi-Fi available.
4. The Exhibitor shall indemnify and hold harmless the Tulip Time Run, MVP Athletic Club, its agents, employees and contractors against any and all costs and liabilities of every kind without limitations arising from use or occupancy of the space.
5. The Exhibitor shall comply with all rules and regulations of the Tulip Time Run and MVP Athletic Club, which govern the exhibition, including those concerning assembling and dismantling of exhibits and conduct of Exhibitor’s contractors, employees and patrons.
6. Tulip Time Run reserves the right to review and pre-approve all participant exhibits and deny or limit the participation of any Exhibitor. Presenting partner exclusivity prohibits the participation of any other fitness centers, gyms, and the like. In the event Exhibitor’s participation is denied this Agreement shall terminate and said Exhibitor shall waive any claim for damages or compensation, except the prorated return of the amount paid after deduction of actual expenses incurred by the Tulip Time Run in connection with the exhibition and there shall be no further liability on the part of either party. Any illegal, offensive, or vulgar materials or products shall not be displayed. Exhibitor further agrees not to display any intellectual property owned by third parties without the express written consent of said parties.
7. Exhibitor agrees to have their booth set up by 3:30pm, staff their booth area during show hours (4pm - 7pm) and will begin booth/exhibit tear down only after the show closes at 7pm.
8. No refunds will be given for cancellation.
9. This contract contains the entire agreement of the parties and may not be altered or modified in any way unless duly endorsed in writing hereon. This contract shall only be effective upon execution of the Tulip Time Run.
